Councillor Bridget Flanagan did not take part in the discussion concerning the following planning application.

i 66 Common Lane – 17/02563/HHFUL – Extension to existing single storey detached garden room.

RESOLVED to make no observations for or against, but to query whether the original structure (garden room) had planning approval.

ii Littlebury Farm, Moats Way – 17/02535/HHFUL –Outbuilding for storage and workshop.

RESOLVED to recommend refusal because there was insufficient supporting and background information. It was also noted that the proposed structure was very large for the site.

iii 74 Common Lane – 17/02651/TREE – T1-Silver Birch thin crown by 25% to allow more light through the canopy, T2 – Horse Chestnut remove deadwood, T3 Horse Chestnut raise lower canopy up to 4m and remove deadwood, T4 - Ash remove hanging limb and deadwood, T5 – Crack Willow overall crown reduction by 3m.

RESOLVED to defer the decision to the Hunts District Council tree officer.

Concern was expressed that the thinning of the silver birch could be detrimental to the tree.
